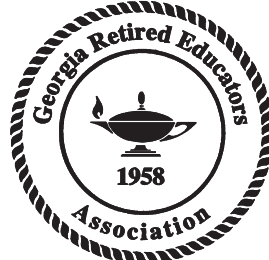

## *Justice Robert Benham, Rev. Claude McBride To Highlight 2005 Convention*

The Annual GRETA Convention will again this year feature two well-known and accomplished Georgians as keynote speakers. Georgia Supreme Court Justice Robert Benham, whose biographical background was published in the *Winter Bulletin*, will be the featured speaker at the Convention Banquet on Wednesday night. Benham spoke at the 1999 GRETA convention and challenged the attendees to "stand firm with strong family and moral values."

Reverend Claude McBride, who is currently serving as an associate in the University of Georgia Alumni Office, will be the guest speaker at the convention luncheon on Wednesday. Before working with the Alumni Association, McBride was pastor of the Milledge Avenue Baptist Church in Athens and was recently named Pastor Emeritus. He is a native of Columbus and a graduate of UGA and the Southern Baptist Theological Seminary. McBride served as Chaplain for the Georgia Bulldog football team for 32 years and presently is Chaplain Emeritus. He is active in church and

community affairs in Athens and Clarke County. He is a popular convention and after-dinner speaker who both entertains and inspires his audiences.

President Zimma Jones said, "We are very fortunate to have two such prominent Georgians as speakers for the convention. Much work has gone into planning and preparing for the 47th Annual Convention, which we hope will be enjoyable and meaningful for all of the attendees. I look forward to seeing many of you in Augusta."

## *Convention Tour*

As part of the 47th annual convention a Historic Driving Tour of Augusta will be available on Wednesday, May 4th. The tour will include the Historic Downtown District, the Augusta Canal Area and beautiful Summerville.

On the tour of Historic Downtown participants will see such landmarks as the Imperial Theatre; the Lamar Building, Augusta's first skyscraper; the Site of the Great Fire; Artists' Row, the Boyhood Home of President Woodrow Wilson; the Amanda America Dickson House; and some of Augusta's most prominent historic churches.

Built in 1845 as a source of water power to attract manufacturing to the South, in its heyday an estimated 250,000 bales of cotton moved along the banks of the Augusta Canal. Today the canal is one of 18 nationally-designated heritage areas and popular spot for walking, biking, and canoeing. The canal is also the location of the historic Enterprise Mill which is listed on the National Register of Historic Places.

Summerville is the hilltop Augusta neighborhood which dates back to the late 1700's as a distinct community, separate from Augusta. Large tracts of land on the hill were acquired by prominent Augusta citizens like George Walton, John Milledge, Governor of Georgia and Thomas Cuning. Many such citizens used their hilltop homes only during the summer months when the heat and humidity along the Savannah River made their Augusta homes uncomfortable.

The tour will depart 2:15 p.m. and all participants should assemble in the lobby of the Radisson Riverfront Hotel at 1:45 p.m. The cost of the tour is \$15.00.

# 2005 Proposed GREA Bylaw Amendments

The following eight proposed Bylaw amendments were recommended by the GREA Governing Board at its meeting on January 20, 2005. In accordance with GREA Bylaws Article XIII, Amendments to the Bylaws, the following recommended changes will be presented at the Annual Convention to be held May 3-5, 2005. A two-thirds vote of the members present is required for approval.

## PROPOSED BYLAW AMENDMENT #1

Article I, Section 3—Motto

This recommendation changes the motto to place service before support.

Proposed Motto: FELLOWSHIP... SERVICE... SUPPORT

Current Motto: FELLOWSHIP... SUPPORT... SERVICE

## PROPOSED BYLAW AMENDMENT #2

Article VII, Section 6, E—The Treasurer's duties are as follows:

Add the following:

5. Assist the President-elect in preparing the budget.

## PROPOSED BYLAW AMENDMENT #3

Article VII, Section 5—Local Units

Add the following:

B. All officers of local units shall be required to be GREA members.

Renumber the current Article VII, 5, B to VII, 5, C.

## PROPOSED BYLAW AMENDMENTS #4, #5, AND #6

Article VIII, Section 2—Standing Committees

Change items VII, 2, B, 1—Membership;

VIII, 2, D, 1—Public Information and Program Planning;

VIII, 2, J, 1—Service to Members,

to all read as follows: "The committee shall consist of a chair and at least two other members."

Currently these items are different and they read as follows:

VIII, 2, B, 1—"The committee shall consist of a chair and at least two, but no more than five members."

VIII, 2, D, 1—"The committee shall consist of a chair and at least one other member."

VIII, 2, J, 1—"The committee shall consist of a chair and at least three other members."

## PROPOSED BYLAW AMENDMENT #7

Article IX, Section 1—Vacancy in office of Area Director

Add the phrase, "or for any other reason," so that the item reads as follows:

"A vacancy in the office of Area Director resulting from the failure to nominate at the appropriate time *or for any other reason* shall be filled by the candidate recommended by the Executive Committee and approved by the Governing Board."

## PROPOSED BYLAW AMENDMENT #8

Article IX, Section 3—Other Vacancies

Change this section as follows:

Proposed wording: "A Vacancy in the office of President-elect or Secretary resulting from failure to nominate at the appropriate time or for any other reason shall be filled by the candidate recommended by the Executive Committee and approved by the Governing Board."

Current wording: "A vacancy in any other office shall be filled by the Governing Board upon the recommendation of the President."

# Clara W. West 1977-1978 GRTA President, Dies

Clara Williams West, Thompson, 1977-1978 President of GRTA passed away at her home on November 21, 2004. Clara West believed that, "learning was living and the more you learned, the better you lived. Wherever she went she would extract the best and bring it home to her family, church, and community."

West graduated from Paine College in 1928 and earned her Masters degree from Atlanta University. She was married to the late Rev. John H. West who served as GRTA President in 1973-1974. They are the only couple who have both served as President of GRTA in the history of the association. Mrs. West

served in leadership roles in her church and in her community. She was a leader in obtaining equal rights for African Americans in both the political and educational arenas. GRTA was fortunate to have the leadership of a person of her vision, commitment, and compassion. A tribute to Mrs. West included a poem from Helen Steiner Rice, a portion of which reads,

*"And for my sake and in my name  
Live on and do things the same  
Feed not your loneliness on empty days,  
But fill each waking hour in useful ways."

# Legislative Report

This update is being written with six Legislative Days remaining in the 2005 General Assembly. As projected, this has not been "business as usual" as the citizens of Georgia elected the first Republican leadership in 134 years. Georgia, and the nation, have new political direction and focus with change being an ongoing process.

From my experiences this session, I am firmly convinced that GREA and the Senior Citizens of Georgia could not be in better political hands than the House and Senate Retirement Committees. Both are highly motivated and keenly interested and have outstanding leadership in Rep. Ben Bridges and Sen Bill Heath.

The Legislative Priorities set by your Legislative Committee have been addressed during this session:

- Our Cost of Living increases appear secure.
- Pension Equity, for our oldest members, is on the agenda for the House Retirement Committee Summer Study. These increases are within the authority of the TRS Board and Dr. Gardner and I continue to work this opportunity. This is HB 400 authored by Rep. Brooks Coleman.
- HB 495, which corrects the TRS concerns with last years Return to Work Law needs only Senate approval and is on track for approval. Every effort was made to move the retirement date to 12/31/05 but it met opposition.
- The Governor included funds in the Budget to help with increasing costs and retirees can expect options when we renew coverage this spring.

As we go to press a major battle is going on in the Senate over Venture Capital Investments using retirement funds. We have opposed this activity at every step and GREA and PAGE stopped this bill at the Committee level last week. It has now been attached to a House Bill that passed the House and the data used by GREA and PAGE has been distributed to every member of the House and Senate. Local Retirement Association assistance will be needed to defeat this attempt and the courage of Chairman Heath is deeply appreciated.

It has again been a pleasure to represent you at the Capitol. On behalf of the Legislative Committee, I want to thank the local unit Presidents and all members who worked to assure that their local elected delegations knew that GREA was politically active. This year members of the General Assembly were provided with a Directory of Education Advocates and the Georgia Retired Educators Association is included.

## AARP 55 Alive Driver Safety Program

The 55 Alive Driver Safety Program is designed especially for motorists age 50 and over. It is intended to help the mature driver improve skills while learning to avoid accidents and traffic violations. The program is aimed at improving road safety by helping drivers become more aware of factors that can affect their ability to drive as they grow older.

In two four-hour sessions, the program covers topics of interest and relevance to today's more experienced driver, including adjusting for changes in vision, hearing and reaction time, avoiding driving hazards and handling various road challenges.

AARP makes this program available to drivers for a nominal fee. Most companies give an auto insurance discount for completion of this course. No tests are given.

## DOUGLAS COUNTY WINS AWARD FOR HIGHEST INCREASE IN TOTAL MEMBERSHIP

The Douglas County REA received the award for the highest increase in total membership in Class AA at the 2004 Annual Convention. Agnes Greene, the Douglas County REA Membership Chair gets the names, but not the addresses or phone numbers, of all of the retiring educators from the Douglas County School System. Agnes divides the names among the members of the Membership Committee, who then look up addresses in the telephone book. This is a time-consuming activity, but is manageable if enough people are involved. For those retirees for whom addresses cannot be located in the phone book, the committee members try contacting educators who worked in the same school for helping in locating addresses. In all except the largest systems, someone in the local unit usually knows the retiree personally. They also make use of the internet to locate addresses. Through this variety of resources and persistence they have been successful in locating the addresses of over ninety percent of the new retirees.

Then the process of contacting the retirees and inviting them to attend and join the local unit and GREA begins. New retirees are contacted by phone, letter or personal contact and invited to a monthly meeting. For those who do not join in the spring just before retiring, they are invited to the first meeting of the new year in September and again in October. It is due to this deliberately planned and organized effort that Douglas County REA was able to receive the largest increase in total membership for the 2003-2004 year. The DCREA Membership Committee is happy to share these ideas with other units. When asked, "How do you achieve membership growth?", someone said, "We work at it every day."
