# Fall 2018 GREA and GREM Governing Board Meeting

The Fall 2018 Governing Boards met at the beautiful Legacy Lodge at Lake Lanier Islands in Buford, Ga. on October 30th and 31st. The meetings were led by GREA President Mickey Wendel and GREM President Myrtice Johnson and there was a very positive spirit of working together to achieve some very wonderful outcomes. Treasurer Dr. John Upchurch reported that the GREA and GREM finances were in great shape with well over \$600,000 in the bank. He reported that GREA would have a CD worth \$203,765.13 coming due on November 1st. Then the GREA and GREM Finance committees, President Wendel and Johnson along with Executive Director Dr. Bill Sloan, recommended to both boards that we take the money and apply it to our mortgage on the State Office/Museum building. Both boards unanimously approved this additional payment on the principal and it brought our total mortgage down to \$174,008.20.This bold initiative will reduce the amount of interest that we are paying each month. After this additional payment on the principal we saved approximately \$900 in interest on the next month's payment. Your Governing Board is doing an outstanding job on reducing our debt. The Governing Board wishes to thank each and every one of you who have bought a brick or helped find a new member. GREA and GREM will be totally debt free in the very near future. We are truly blessed with a lot of retirees helping GREA and GREM. Our future is bright!

Our second humanitarian project is to promote Kids Heart Challenge (formerly Jump Rope for Heart) in the schools in your county. Please communicate with Beth Stewart via email at beth.stewart@heart.org. She can help you identify schools in your county that have not traditionally participated in Kids Heart Challenge. Your communication with Beth is the only way we will know if GREA is making a difference. The funds raised from this event will fund heart disease research which could actually save your life or the life of a love one. A primary goal of the American Heart Association is to use Kids Heart Challenge to educate our children about heart disease and how to avoid life threatening problems through good eating habits and exercise.

Some units have struggled to earn the Spotlight Award. A generic cover letter for Spotlight Ads has been sent to all unit presidents via email from Dr. Sloan. Several units requested such a letter to add credibility to their requests. The letter can be modified to meet the desired requirements for your unit. For reporting to the state, you only need the company name, address and phone number. Your local unit may request more information from the company depending on how you share Spotlight Ads within your local unit. No one is required to use the letter. (Some of you have proven methods for selling ads. Keep it up!) Your members can simply hand the Spotlight Ad letter and form to a business they use as they are paying their bill. Do not forget to contact schools and churches. When schools and churches are made aware of how much free volunteer service they are receiving from retired educators, there should not be any problem with supporting GREA with a Spotlight Ad.

Not only did MASA pay the cost of our transportation and the medical personnel, they also got us quickly through customs in both leaving Jamaica and re-entering the U.S. I can't possibly say enough positive things about MASA insurance, and I highly recommend it to everyone. As we approach the New Year I want to thank President Mickey Wendel for his positive leadership of this organization. He has made a real impact all over the state with his "Share the Light" agenda. I have thoroughly enjoyed working with him this year. GREA is very fortunate to have him as our President.

After we become debt free it will be exciting to see what happens with GREA in the next 10 years. I can foresee some very exciting things on the horizon for GREA and GREM.

Last year we sold over 460 bricks and recruited over 2,500 new members thus making it possible for us to pay an additional \$203,764.00 extra toward "principal only" on the mortgage without having to ask you, our members, for additional monies. You did this with your hard work in membership recruitment and brick sales. We can do it again because we established the facts last year that we are all truly *Champions* who are now *Sharing the Light* in our great organizations. With your continued support, *we will share the Mortgage Burning Ceremony with you at the Convention in May 2019.* 

The Museum/Curator Committee under the leadership of Marsha Wendel is continuing to work on new plans for the updating of the museum with its timeline recording Georgia's History in Education from inception to the present. A brochure of the Museum has already been developed and approved by the GREM Board and will soon be ready for printing. Our hope is to be able to provide information about the Museum for the purpose of marketing and advertising throughout the state of Georgia.

What do I want for Christmas? Yes, you've guessed it! All I want for Christmas is a *debt free* Museum for GREA and GREM. Thank you as always for your continued love and support of our great organizations.




