## Remember "Why" Educators Have Teachers Retirement

Greetings to our GREA friends all across Georgia and beyond! Over the past couple of months, I have had the opportunity to travel across Georgia, to Texas, New Mexico, and Arizona as a part of my work with TRS representing our retirement system. I always enjoy meeting with both active and retired educators, and sometimes you get to experience some meetings that are especially memorable. Getting reacquainted with educator friends in all of these places is just wonderful. Recently, in Toombs County, I even got the opportunity to reacquaint with my 6th grade math teacher from Union Elementary School in Bibb County from 1968! Dr. Cuba McKenzie, who went on to become a dean at Valdosta State University, like every teacher that I had during school, impacted my life. In that today we deal with budgets and investments that are dependent on knowing math to some extent, you too might be thankful for Dr. McKenzie's influence in my life!

In this writing, I want to remind each of us as to "why" teachers have a defined benefit retirement plan in Georgia and in most every state in the country. The defined benefit plan for teachers exists as a significant component of educator compensation and educational policy in our state. Governor Ellis Arnall spearheaded the effort to begin the retirement system. He stated in his support of the retirement plan that "he wanted retired educators to be able to live out their retirement years with dignity."

That statement, while we agree with it, is not the only reason that the retirement system exists. From an educational policy perspective, the plan exists largely for the purposes of 1) recruiting quality educators into the profession, and 2) retaining educators into the profession who could otherwise find jobs elsewhere earning higher salaries.

Research on student achievement consistently reflects that the variable most influencing student learning is teacher quality. That clearly supports the need and desire to recruit quality teachers into a profession that has traditionally paid less than many other competing professions. Then, when it comes to retaining teachers, I clearly remember my freshman year in college when my algebra teacher resigned during the quarter to take a job outside of academia. We basically were left in a bad situation for the remainder of the quarter. Such an occurrence would likely be more common if we did not have a retirement plan that encouraged teachers to remain in the profession. With significant turnover and leadership changes taking place in our own Georgia legislature in the coming year, we all can have a role in helping to explain why the defined benefit plan works to positively influence education in Georgia.

Thank you for your past service to education in Georgia! Thank you, as well, for your continued service as you support the profession by being an active member in your local retired educators association as well as GREA! We sincerely wish you all a wonderful Thanksgiving and holiday season bringing us into the new year.

The 2022 Retiree Option Change Period (ROCP) marked the first ROCP with in-person meetings since the pandemic started.
