## TRS Board of Trustees Chairperson becomes President of the National Council on Teacher Retirement

Hello to all my Retired Colleagues.

I am Debbie Simonds. I retired from Gwinnett County Public Schools in May 2010, after having served as a teacher in Public Education for 35 years.

On October 14, 2020, I will become the President of the National Council on Teacher Retirement (NCTR). Given the challenges we face today of COVID-19, attacks on Pension Plans, and the wildly fluctuating markets, I will have a lot of work to do! But I am a teacher and we never back away from a challenge!

Let me share with you some background on NCTR and why it is important to all of us. NCTR began in 1924. It is now constituted as an independent association dedicated to safeguarding the integrity of public retirement systems in the United States to which teachers belong. The membership includes 63 state, territorial and local pension funds. These systems serve more than 19 million active and retired teachers, non-teaching personnel, and other public employees. The combined assets of these funds have more than two trillion dollars in their trust funds. NCTR is recognized as the preeminent voice for Teacher Pension Plans on a National level.

My involvement in NCTR began within three weeks of my being elected to the Georgia Teachers Retirement System Board of Trustees by the Board of Trustees.

I knew I had a lot to learn and NCTR offers specialized training for Trustees in the areas of finance, pension policies, trustee fiduciary responsibility, state and federal legislation affecting pensions, and informing us on the threats to public pension plans. I have now participated in over 100 hours of specialized Trustee training with NCTR. Dr. Bill Sloan has also been an active member of NCTR.

I soon learned that NCTR has committees and a Governance structure that determines the goals and objectives for the Organization. One of my goals was to ensure that Georgia has a voice on national issues. To that end, I have served on two NCTR committees and then ran for a Trustee position on the Executive committee. After serving a term on the Executive committee I ran for President-elect which leads to my being NCTR President in October 2020.

I am deeply humbled by the support from the members of NCTR and TRSGA in electing me to be the next President.

I want to take a moment and thank you. By being a member of GREA you have taken up the challenge to be a part of the important work of safeguarding our pension plan. I am always grateful to each of you every time a pension-related issue comes before the General Assembly. GREA is a force to be reckoned with at the Georgia Capitol!

My pledge to you as a Trustee and Chairperson for the Georgia Teachers Retirement System and in my upcoming role as the President of NCTR is to work diligently to ensure that pension plan members can retire with dignity.

Together we will succeed.

# TRS in This Time of Challenge

*Buster Evans* Summer and back to school greetings from your Teachers Retirement System of Georgia! There is no doubt that we are experiencing some of the most challenging times our world has ever experienced. Our active/working members, including teachers, administrators and others who support the educational process, are currently making some of the most difficult and perhaps controversial decisions one could imagine. Many of our retirees fall into the high-risk category for Covid-19 exposure. Our thoughts and prayers are with all of those that we serve as well as our leaders that make challenging policy decisions impacting all Georgians.

## ***COVID-19 and Retirement Implications.***

In mid-March, TRS, like most state agencies, began doing the majority of our work remotely. This was a tremendous change for our agency, as most of our work has always been onsite and face-to-face with our members. I am extremely proud of our team members who have continued to serve our membership flawlessly to issue benefit payments, counsel and process retirements, work with employers, and all of the other work that supports our over 400,000 members.

Interestingly, the number of new TRS retirees is somewhat lower for this year. I would like to congratulate the 6,116 newly retired TRS members! You are now a member of a very distinguished club that consists of 135,619 retired educators! Thank you for your work in the educational profession. There's no doubt that you helped enrich the minds and lives of Georgia's youth, and now you get to reap the rewards of a retirement plan established by the State of Georgia to provide you with retirement security.

## ***Investment Returns***

Most of you know that investment earnings have been extremely volatile during the past 5 months. In fact, we have seen our TRS fund balance go from over \$84 billion, to less than \$65 billion, and now back up to over \$84 billion. It has certainly been a roller coaster akin somewhat to the recession of 2008 and 2009. The exception during this time has been the recovery, to this point, has been much quicker. Though we did not quite make our assumed rate of return for FY 2020, we did have some of the best returns among pension systems nationally with gains exceeding 5.4 percent for the fiscal year. As I have looked at some of the investment returns from other state retirement systems across the country, I have found that our investment professionals were able to achieve gains that generally exceeded the returns of most

state plans. That means greater security for our current and future retirees. I want you to know that our Governor, his staff, and our legislature have provided the funds necessary to meet the actuarial recommendations for funding continuity. I continue to encourage our active and retired educators to be sure to say "thank you" for their continued support whenever possible.

## ***The Future***

Many of us are in that mode where we are pondering "the future." The future of education will likely look somewhat different than it has in years past. For TRS, the future of how we serve our members will most certainly look different as well. Our goal, though, is to continue to serve our members with integrity and commitment to their needs. Because of that, we will continue to emphasize video and phone-based counseling sessions for our members until we resume face-to-face services. We also have implemented more on-demand content to include videos and podcasts to provide more convenient ways for members and retirees to access information. Accessibility to resources are constantly being transferred to digital mediums and we want to make sure that access to TRS is as stress-free possible. Additionally, I am thrilled to share that we have opened up a TRS satellite office in Macon that will save thousands of educators each year the need to drive all the way to Atlanta for counseling and retirement planning. I want to encourage you to take advantage of our Macon office location to avoid the time and costs associated with traveling to north Atlanta especially if you are driving from the southern and central parts of Georgia.

## ***Working After Retirement***

Each year, approximately 10 percent, or over 13,000 of our retirees return to work on a part-time basis after retirement with a TRS employer. Retired educators serve as a very valuable human resource option for both TRS and other employers. Please be reminded that there are limitations for retirees returning to work for a TRS employer. Our Retirement Services Division at TRS can assist both employers and retirees for guidance in this process. We are pleased to share with you that our new automated return to work approval process has greatly expedited that processing time.

2020 has been and continues to be a different kind of year captivated by the coronavirus pandemic. Even with the pandemic much activity is occurring in the museum, Honor Roll Plaza, and the grounds.

The GREM Curator's Committee, chaired by Marcia Wendel, continues to add elements to the interior of the museum in the quest to tell the story of public education in Georgia. The wall displaying the four periods of Georgia education history is an esthetically pleasing pictorial that achieves this goal. Signage will be added in the vestibule directing visitors into the museum. Additionally, signage will be added in the parking areas directing visitors to the entrance of the museum located on the south side of the building. GREA offices are accessed through the front of the building (north side).

Although visitations to the museum/offices has been almost nil, the Honor Roll Plaza is a source of pride to visitors. # State Health Benefit Plan (SHBP) Open Enrollment/Retiree Option Change Period 2020


The State Health Benefit Plan (SHBP) 2020 Open Enrollment (OE)/Retiree Option Change Period (ROCP) period for the 2021 Plan Year will be here in a few short weeks! From Monday, October 19, 2020 through Friday, November 6, 2020, SHBP active and retiree members will be able to select the health care plan that best suits their needs from available options.

In August, SHBP Executive Director Jeff Rickman presented 2021 Plan Year rates and designs to the DCH Board of Directors and received unanimous approval. Pre-65 Retirees will have access to the same high-quality plan designs that were offered in Plan Year 2020, which include the Gold, Silver, and Bronze Health Reimbursement Arrangement (HRA) Plan Options offered by Anthem Blue Cross and Blue Shield (Anthem), the High Deductible Health Plan (HDHP) Plan Option offered by UnitedHealthcare, the statewide Health Maintenance Organization (HMO) Plan Options offered by Anthem and UnitedHealthcare, and the regional HMO Plan Option offered by Kaiser Permanente.

For our Medicare Eligible Retirees Age 65 or Older, the Medicare Advantage Standard and Premium Plan Options will continue to be offered by Anthem and UnitedHealthcare.

Additionally, CVS Caremark will continue to administer pharmacy benefits and Sharecare will continue to administer the Be Well SHBP® well-being program. Both programs are for our Pre-65 Retired Members and their covered dependents. In addition to previous benefits under the Be Well program, Sharecare is adding the RealAge Program and an Unwinding Anxiety program this year. The RealAge Program is a comprehensive healthy behavior program targeting the four highest lifestyle risks so many face—stress, sleep, nutrition, and activity. Unwinding Anxiety is an evidence-based digital program that combines neuroscience, mindfulness, and proprietary tools to help members identify anxiety triggers and improve your relationship with stress.

SHBP has worked extremely hard preparing to keep members informed of their Plan options even with the COVID-19 public health emergency forcing a more virtual learning environment. Instead of our traditional in-person education sessions, SHBP and UnitedHealthcare are partnering to offer online and teleconference informational sessions for both retirees and active members. Continue to check out the SHBP website for the latest information in the days and weeks to come.

## A Message from AMBA

### *Cancer patients use crowdfunding for medical bills, expenses*

(Reuters Health)—Even cancer patients who seemingly have health insurance are seeking donations online to help with medical bills, travel, drug costs and sometimes living expenses while they undergo treatment, a U.S. study suggests.

Based on a sample of more than 1,000 GoFundMe campaigns seeking money for a U.S. cancer patient, the researchers found that patients only received, on average, one quarter of the funding goal they set. Half the goals were \$10,000 or higher.

They found that the average fundraising goal was \$21,000, and the average raised was about \$5,000. More than 85% of patients were adults. About 40% of campaigns asked for funds to pay medical bills, followed by 25% for medical travel and 23% for non-medical bills.

“The use of GoFundMe shows us a lot of what we already know: that for many, the present safety net is inadequate and can create financial ruin,” Dr. Benjamin Breyer of the University of California, San Francisco, the study’s senior author said. “Getting sick shouldn’t create financial devastation, and patients should have access to affordable, high value care.”

“Research shows the widespread sacrifices that patients and families have to make following a diagnosis, which is important because we often focus strictly on medical costs,” said Matthew Banegas of the Kaiser Permanente Center for Health Research. “So many areas of day-to-day life need attention, and patients don’t have the financial resources to keep up.”

Still, if cancer does happen, you want to be as prepared as possible. Through GREA, AMBA offers members a Cancer Policy that pays a benefit directly to you to help cover out-of-pocket expenses related to cancer diagnosis and treatment. 
