Happy New Year! By the time you receive this *Bulletin*, we will be deep into a Georgia winter. It was 33 degrees this morning when I left home and it is only early December. I hope winter is not going to be terribly bad! I like a little snow occasionally but I hope the ice storms stay away this year!

2019 was the best year ever for GREA! We reached three major milestones that a few years ago looked unattainable for the near future! One, in

We now own a building and grounds worth over \$1.5 million dollars! I am so excited to say that you the membership paid for our building with your dues, buying bricks and donations. There is not one cent of outside money from any source other than our members. Two, in July, we enrolled a lady from Sumter County that made us have 30,000 members on roll. I remember when we were only 15,000 members. You have done a great job recruiting new members for GREA. I thank all of you so much for your work! Three, in late December or early January, we had over \$500,000 in the checking and savings accounts. In 2005, GREA had to delay paying its bills each month until the 15th when the monthly check from TRS would arrive. On occasions the Treasurer and bookkeeper had to take money out of our small money market savings to just pay the bills. You can readily see what membership growth can do. I am thrilled to be a small part of what has happened for GREA in the last 14 years.

The remodeling of the Museum is moving right along. We hope to see it finished in the very near future. Mickey Wendel has an article about it in another section of this *Bulletin*. GREA and GREM cannot thank Mickey and Marcia Wendel enough for what their committee is doing here.

Johnny Smith, our new Director of Communications, is doing an outstanding job for GREA. This is his first edition of the *GREA Bulletin* and it looks great! The biggest challenge he faces is not enough room for the info that you are sharing with him. We needed about eight more pages to do what we wanted in this edition. I hope you understand why your pictures are not here. Room is so limited but every picture that you send to us is shared on Facebook to the world. Keep the great pictures and articles coming to him. He loves sharing your info with everyone.

He just told me my article is too long so I must stop! Thank you GREA members for all you do!

There are several pieces of retirement legislation that we continue to watch including two return to work bills which would potentially expand the options for our retirees returning to work. Finally, there are two bits of news that we think you will like as I close. First, all of our retirees that are COLA eligible will be receiving their 1.5% increase in January. (Did I hear applause?) Second, for the first time ever, our fund increased to over \$81 billion at the end of November. During the past $3\frac{1}{2}$ years, the fund has grown from \$65 billion to over \$81 billion while at the same time over \$13 billion dollars in benefits have been paid. We hope to see several years of continued recovery that further strengthens the sustainability of Georgia's TRS fund.

Past President John A. Demons, Jr. passed away on November 25, 2019. Mr. Demons served as GREA President in 1998-1999 and he led the change of the name of our organization from GRTA to GREA. Services for him were held at the Trinity Missionary Baptist Church in Fort Valley, Georgia on December 2nd.

John was born on February 14th, 1926 in Thomson, Georgia. After a brief stint in the U.S. Army during World War II, he completed his BS Degree in Agriculture at Georgia State College (now Savannah State University) in 1949.
